Passenger Rules

Arrival Time - Be prepared for transit vehicles to arrive 15 minutes before or after your scheduled pick-up time.

Service animals are allowed to accompany owners as per the Americans with Disabilities Act (ADA) of 1990. Animals other than service animals are allowed only in a secured travel carrier. Please inform dispatch of an animal when booking your ride.

Personal care attendants are persons who are involved in the mobility assistance of the attendee and ride free of charge.

Securement - It is required all passengers wear an approved safety device while riding on the bus. Passengers utilizing mobility devices will be required to be properly secured. State laws apply toward child passengers. Car seats are NOT provided.

Packages And Personal Items – Carry-on packages are limited to what a rider can carry in one trip unassisted. Oversized packages will be refused for transport. An oxygen tank must be portable and secured

Cancellation Policy and No Shows -

Cancellations will be accepted up to one hour prior to scheduled pick-up times without penalty. A no show is when a passenger fails to notify at least 1 hour prior to scheduled pick-up time. The driver will wait for five minutes. After five minutes, the ride will be marked as a no show. Suspensions occur after 3 no shows in a calendar month.

- All riders shall stay seated until the vehicle comes to a complete stop.
- All passengers are to be clothed and wearing shoes.
- Riders shall be considerate of others at all times.
- Passengers carrying open alcoholic beverages and/or using illegal substances will not be permitted to ride. Use of tobacco/vaping products is strictly prohibited.
- Riders shall keep hand(s), head, or any other body part inside the bus and within their seated area at all times.
- Riders shall obey the driver willingly and report any problems to the bus driver or dispatcher promptly.
- Riders shall assist in keeping the transit vehicle clean by using sanitary practices.
- Eating in the vehicle is not permitted.
- Closed, sealable containers such as water bottles are allowed.
- No weapons, lighters, or explosives are permitted on the vehicle.
