GENERAL PASSENGER RULES:

The general rules listed below are not intended to be all-inclusive but are considered a guideline for proper passenger behavior.

- ___1. All passengers shall wear the provided lap belt at all times while traveling on the bus.
- ___2. Passengers shall wait until the transit vehicle has come to a complete stop before attempting to board or disembark. All riders shall stay seated until the vehicle stops.
- ___3. No roller skates, roller blades, ice skates, etc., are to be worn in the bus.
- ___4. All riders are to be clothed and wearing some form of protective footwear.
- ___5. While waiting for the transit vehicle at the designated pick-up point, riders shall stay off the traveled roadway at all times. Riders shall not walk along the side, directly in front of or behind the bus for any reason.
- ___6. All passengers will remain seated while the vehicle is in motion and for the duration of their ride.
- ___7. Passengers shall be considerate of others at all times. Threats, hitting, tripping, shoving, kicking, spitting, foul language, horseplay, teasing or any other improper or disruptive behavior towards anyone or themselves will not be tolerated.
- ___8. Devices, such as radios or any other electronic device, can only be used with headphones.
- ___9. Passengers carrying or using alcoholic beverages and/or illegal substances will not be permitted in the transit vehicle.

- ___10. Passengers shall keep hand(s), head or any other body part inside the bus and within their seated area at all times.
- ___11. Passengers shall obey the driver willingly and report any problems to the bus driver or dispatcher promptly.
- ___12. Passengers shall assist in keeping the transit vehicle clean by using sanitary practices. Any offensive odors to others or any type of unsanitary practices are to be avoided.
- ___13. Eating in the vehicle is not permitted. Drinks with securable lids are permitted.
- ___14. Use of tobacco products is strictly prohibited (this includes vapor and e-cigarettes).
- ___15. Lighting matches, lighters, or any other type of flammable material is not permitted on the vehicle.
- ___16. Any type of perceived, suspicious or actual explosive device or weapons are not allowed on transit vehicles.

**After drop off, HCRT is not responsible for the behavior or destination of the child.
However, any suspicious behavior will be reported to the parent.**

I attest I am the parent or legal guardian of the above child. I further agree my child shall be instructed on the above rules and shall abide by these rules and the policies/procedures outlined under the Youth Rider Program and the *Passenger Handbook*. I understand that any violation of those rules, policies, and/or procedures may result in my child being barred from riding unattended.

I acknowledge I will be required to notify HCRT in case of any alterations to my child’s scheduled trip. HCRT will not take other ride destination instructions from my child.

I understand HCRT and Brown Transit, LLC are not responsible, nor liable for my child except for the period commencing embarking on a transit vehicle until termination when dis-embarking from the vehicle.

I further understand I will be responsible for keeping the Youth Registration Form up to date and will request and submit a new form every 6 months during the term of the ride necessity.
